## FROM PAUL NIX:

## THE BOARD MEETS

Ed Dodson was elected president at the February meeting of the Board of Trustees. Ed is a supervisor of quality control at Federal National Mortgage Associates and is involved with investment finance. George Collins introduced him to the Georgist philosophy five years ago at the Philadelphia school where Ed later became a faculty member.

In addition, Ed is also Deputy Director of the Council of Georgist Organizations and co-editor of *Equal Rights*. Having received a B.B.A. at the University of Shippensburg in PA., he is currently a Master's degree candidate at Temple University in Philadelphia. Ed Dodson's articles have appeared in *Focus Magazine* and *The Philadelphia Economists* among others.

## *LONG ISLAND*

### **SEMI-ANNUAL CONFERENCE DEBATE**

At the Semi-Annual Conference on April 18, William Stocker and Albert Fink will debate Saul Rosen and Miriam Peretsman on "Protectionism versus Free Trade." Stocker, state treasurer and Nassau County Chapter treasurer of the Libertarian Party, with Fink, faculty member of the Henry George School on Long Island, will debate for free trade. Rosen and Peretsman, who are both affiliated with the International Ladies Garment Workers Union, will debate for protectionism. The debate will be held at the Plainview Library from 10 to 12:30 pm. A ceremony commemorating the 100th anniversary of the publication of *Protection or Free Trade* will precede the debate.

### **PROCLAMATIONS**

The Long Island School continues to receive more proclamations. As noted in last month's issue, the School has requested surrounding townships to declare May 5th "Henry George Day" in celebration of the centennial of *Protection or Free Trade*. New proclamations include those from Michael LoGrande, town supervisor of Islip, and Peter Cohalan, County Executive of Suffolk County who said a proclamation will be issued.

## *DELAWARE*

The Baltimore Hyatt Regency Hotel was the meeting place for the Mid-Atlantic Regional Conference held on February 13. Frank Nelson, state coordinator of Delaware, conducted a seminar "The Land Question—Perennial Search for Justice and Equality." The sizeable turnout at the conference included highschool teachers who were introduced to ideas discussed in the Land and Freedom Series.

## *LOS ANGELES*

The Alumni Group of the LA School announced new topics for available speakers. Among the topics are, "The Case for Free Trade," "There are no Such Things as Trade Deficits," and "Our Empty World Needs More People."

## *SACRAMENTO*

The Sacramento school has sent copies of a series of articles entitled "Special Report/The Legacy of Proposition 13" to all state legislators in California. These articles examine the effects of the "tax revolt" on public and private sectors. The objective of this mailing was to urge legislators to make changes in the Proposition which would "protect homeowners while still providing local governments with sufficient income. . ."
