

# Acknowledgments

IT IS, alas, impossible to acknowledge all the friendly aid that has been given me in the studies preparatory to this biography. Kentuckians have long been notable for hospitality and for an interest in their own history—an interest which appears in every walk of life. Many a useful bit of information has been provided by men whose names I still do not know, and though such data naturally have to be supported by documents before they can be used, I am none the less grateful for them. A friendly state policeman helped me find the ravine used by the Indian kidnappers who stole Daniel Boone's daughter. Residents on the scene supplied the inscription which had vanished from a tablet. In one county courthouse, the janitor admitted me to the impeccably kept eighteenth-century records with a genial drawl of "He'p yo'se'f, suh." On another occasion, the judge himself did the honors. A busy lawyer made time for me in the midst of business hours. A railroad executive let me browse for a long evening among his Boone notes, manuscripts, and bibliographies, better arranged than those of many a professional scholar. A farmer took time to show a total stranger the pioneer carving on the mantel of his eighteenth-century home and to identify the exact spots where the Indians came raging across the peaceful acres that he now cultivates.

Even an indignant little group at the country store opposite Boonesborough at length magnanimously admitted that perhaps after all it was permissible for a Yankee to write the life of Daniel Boone—at least, a Pennsylvanian Yankee, since Boone also came from Pennsylvania.

Everywhere there was a friendly willingness to help an investigator—no matter how much time he took or how many questions he asked—and an equally friendly interest in his studies, all a refreshing contrast to the attitude one sometimes encounters in the archives of less hospitable lands.

Though one cannot acknowledge so many debts, it is pleasant to be able to set down a few of the greatest. I have had every aid in a number of libraries, especially the Library of Congress, the New York Bar Association, the New York, Boston, Cincinnati, Detroit, Denver, and Lexington (Kentucky) Public Libraries; the Harvard College Library; the Henry E. Huntington Library; and the Columbia, New York, Virginia, North Carolina, Kentucky, Wisconsin, and Chicago University Libraries. The specialized libraries of various historical societies have been equally generous, notably those of the Historical Society of Pennsylvania, the Presbyterian Historical Society, the Kentucky State Historical Society, the Filson Club, the Wisconsin State Historical Society, the State Historical Society of Missouri, at Columbia, the Missouri Historical Society, at St. Louis, the Western Reserve Historical Society, at Cleveland, and the Historical Society of Berks County, Pennsylvania.

Individual librarians have been tireless in locating obscure manuscripts and the rarer printed sources. Among them, I am especially indebted to a group of New York University librarians: Mr. Robert B. Downs, Director of the Libraries; Dr. Theodore F. Jones, Director of the University Heights Library; Mr. Mulford Martin, Librarian of the Commerce Library; Mr. Nelson W. McCombs, Librarian, Mr. Alfred B. Lindsay, Assistant Librarian, and Mr. H. Gambier-Bousfield, Chief of the Readers' Department, of the Washington Square College Library; to Miss Gladys Sanders and Miss Winifred Ver Nooy, of the University of Chicago Library; and to Mr. W. B. Briggs, Mr. R. H. Haynes, and Miss Alice Reynolds, of the Harvard College Library.

A form letter asking for Boone manuscripts, sent to every college and university library in the United States, has invariably met with prompt and courteous attention and has in several cases unearthed new and unsuspected material. Several hundred librarians cheerfully aided in this search and made numerous suggestions.

The keepers of archives in the various state historical societies have submitted to endless questioning with an admirable grace and intelligence. It is a pleasure to return thanks for months of detailed correspondence with Dr. Louise Phelps Kellogg and Miss Annie A. Nunns, of the Wisconsin State Historical Society, whose intimate familiarity with the Draper MSS. and with frontier history has been invaluable. Other specialists who have been generous both of time and knowledge are Dr. Thomas C. Pears, of the Presbyterian Historical Society, Philadelphia; Mr. Julian P. Boyd, of the Historical Society of Pennsylvania; Miss Ludie J. Kinhead, of the Filson Club,

Louisville; Mr. G. Glenn Clift of the Lexington Public Library; Mrs. Jouett Taylor Cannon, of the Kentucky State Historical Society; Miss Nettie H. In Kentucky, Judge Samuel M. Wilson, Mr. C. R. Staples, and Mr. C. Frank Dunn, of Lexington, gave me every possible assistance and free access to the special materials in their possession. Professor Jonathan Truman Dorris, of the Eastern State Teachers College, Richmond, Kentucky, not only guided me to the scene of Twitty's Fort, but also opened to me the hitherto unused MSS. in his possession. Mrs. Mary T. Moore, Librarian of the Kentucky Collection, in the Western State Teachers College at Bowling Green, provided special analytic bibliographies, called my attention to several rare items, and arranged for copying. Professor W. S. Lester, of Kentucky Wesleyan, very kindly sent his collection of photostats to New York for me to use at my leisure. Mr. Charles L. Clift, Circuit Court Clerk of Mason County, Kentucky, was particularly helpful with the records now in his care. Dr. Frank T. McFarland, Professor of Botany in the University of Kentucky, has provided material on canebrakes.

J. Henry Bartlett, Custodian of Records of the Yearly Meeting of the Religious Society of Friends, Philadelphia, S. Irene Eavenson, Secretary of Exeter Meeting, and Miss E. Virginia Walker, of the Friends Historical Library of Swarthmore College, kindly allowed me to use the Friends records in their charge. Miss Elizabeth Madox Roberts, the novelist; Mr. P. M. Hamer, Chief of the Division of Reference, National Archives; Miss Mildred Rex, of the State Historical Society of Colorado; Mr. John Van Male, Director of the Bibliographical Centre for Research, Rocky Mountain Region, of the Denver Public Library; and Dr. Willard Rouse Jillson, of Frankfort, Kentucky, have all been helpful in securing special data.

Mr. M. W. Stirling, Chief of the Bureau of American Ethnology, Smithsonian Institution, has aided me with the various problems raised by Boone's Indian friends and enemies; and Professor C. F. Voegelin, of De Pauw University, one of the few living scholars acquainted with the Shawnee language, has kindly aided with Indian linguistics. Dr. Roy B. Cook, of Charleston, West Virginia, has been of great aid in verifying local documents. Dr. Archibald Henderson has helped me with disputed points in Boone's early life in North Carolina; and his published writings have been unusually

valuable. Mr. Horace F. Grimm, State Director of the Historical Records Survey in Missouri, aided by his field worker, Mr. C. A. Pigg, has had church and county records in St. Charles examined for me, and in so doing has uncovered several unknown legal transactions by Daniel Boone and his relatives. Miss Elizabeth B. Parker, State Director of the Historical Records Survey in Virginia, and her field-worker Miss Ruth Sweeney, have done me a similar service with the Daniel Boone records at Christiansburg. Senator C. Hale Sipe, of Freeport, Pennsylvania, helped me locate the Revolutionary cartoon reproduced facing page 164 and now in the possession of Mr. Earle R. Forrest, of the *Washington Reporter*, Washington, Pennsylvania. Mr. Forrest has generously given me permission to include this unique bit of Americana, first printed in his *History of Washington County, Pennsylvania*. The Reverend Father W. B. Sommerhauser, S.J., rector of St. Charles Borromeo, St. Charles, Missouri, supplied the record of Daniel Morgan Boone's wedding from the parish archives. Miss Marcia Williams, of O'Fallon, Missouri, went to considerable pains to secure local information for me. Dr. Francis B.
