W. J. Wallace on California

WORD has been received from Mr. W. L. Ross that, because of the defection of the Los Angeles Single Tax League, the Great Adventure organization will be unable to get the signatures necessary to an initiative petition to place the Single Tax constitutional amendment on the California ballot for the coming election.

To those of us who looked with hopeful eyes to the strong and courageous leadership of Luke North in the campaigns of 1916 and 1918, and to the continued public interest and approval displayed by the vote of nearly 200,000 in the election of 1920, this abandonment by the California leaders of further political effort will require a much more satisfactory explanation than has been given, to relieve them from the reproach of betraying the voters who have supported them, the contributors who have sustained them and the Single Taxers throughout the world who have earnestly hoped for their success.

Indifferent and fainthearted, they have retreated to the easy and peaceful programme of education.

That programme does not necessitate results in any specific time, nor does it require any specific results at any time. It can be indefinitely prolonged. Under it no test occurs to determine whether more people are learning about the Single Tax than are forgetting about it.

Education proceeds best in quiet rooms where the student, calm and undisturbed, can follow the arguments of Henry George or of Patrick Edward Dove to their conclusion. But students are rare. Most people learn by contact with their fellow men, in their families, their schools, their business and social relations; and what is interesting to the public at large is certain to have some effect on them. What is not of public interest seldom reaches them and the advocates of new and unaccepted doctrines are usually disregarded until a general interest is created.

If education is the desideratum, the facilities for it in California under the election laws of that State are vastly superior to any other kind of educational effort.

The character of the education that may be expected can be judged from the following extract from a recently published letter by the publicity director of the Los Angeles Single Tax League. "When the voters feel themselves reassured that the Single Tax will not disturb their title to land or other property in any way, shape or manner, the measure can be put on the ballot and carried."

This surely cannot mean that only the title to land will not be disturbed, but that the rent of the land will not be taken for the public. So, to make the assurance still more satisfying and to give the necessary definiteness to it, there should, of course, be added some such phrase as the following: "and will not in any way interfere with the emoluments now drawn or which are expected to be drawn from land."

If this is Single Tax, another name must be found for those of us who do not subscribe to this statement as our belief. In recent campaigns the interest of the California voters was so aroused that the opposition became apprehensive. The speculators in land privileges (among whom, regrettably, are some who claim to be Single Taxers), recognized the danger and an Anti-Single Tax League was formed. This opposition would have forced the question to the front of public discussion. What a grand opportunity for educational work!

The California leaders then withdraw and leave the enemy in undisturbed possession of the State.
