



Forthcoming International Conference For Land Value Taxation and Free Trade

Odense, Denmark, 28th July to 4th August



Repeating our announcements of the forthcoming International Conference, we invite again the support of our readers by their joining the roll of membership, whether they are able to be present or not. Membership of the Conference is open to all who subscribe to the International Union (form for new members is inserted with this issue) and who pay the Conference Fee of £1 or \$3. Enrolments are being received in a steady stream and the accommodation for attending members is filling up, so that decision as to coming should be made without delay.

The success of the Conference is abundantly assured. The programme is well advanced. It will be highly attractive with special papers presented by authors from Denmark, Great Britain, the United States of America, France, Sweden, Australia and other countries; the Presidential Address by Mr. J. Rupert Mason; these all being printed in both Danish and English; an authoritative and instructive demonstration by lantern and screen of the Danish procedure for land valuation; short addresses on the status and progress of the Henry George movement in various countries; official reception; participation by Danish parliamentary leaders at a large public demonstration; informing whole-day excursion to inspect typical farm holdings and learn much of Danish agriculture and country institutions; arrangements for broadcasting some of the proceedings; the lighter side of the Conference well catered for by various entertainment; the People's High School, where the Conference assembles, beflagged with the flags of many nations; and as at all Danish meetings of the kind, there will be music and song. English-speaking and Danish twin-Chairmanship at each session and all discussion made easy flowing.
