

ACKNOWLEDGMENT

THIS CURIOUS STORY has never been told before—no biography of Lord Lucan, Lord Cardigan, or Lord Raglan having, as yet, been written. It has emerged piece by piece from private letters and diaries, from dispatches and War Office correspondence, from law reports, from files of newspapers, and from privately printed pamphlets preserved in country houses.

I am above all indebted to the Earl of Lucan, M.C., who with great generosity placed his family papers unreservedly at my disposal. Without his support and information this book could not have been written. I have received valuable assistance from Mr. George Brudenell, the present owner of Deene Park, and Miss Joan Wake, the Secretary of the Northamptonshire Record Society. I was not only allowed to use the Brudenell papers at Lamport Hall, but was also assisted with much private information.
